

**REQUIREMENTS AND PROCEDURE FOR PARTICIPATION IN CANDIDATE
DOCTORAL COMPETITION by field 3.3 Political Science (Public Administration),
DEPARTMENT OF "PUBLIC ADMINISTRATION", FACULTY OF PHILOSOPHY,
SOFIA UNIVERSITY "ST. KLIMENT OHRIDSKI"**

NECESSARY DOCUMENTS:

1. Detailed academic CV. It should include:

- Academic education;
- Professional experience and/or internships in the specialty,
- Foreign language knowledge;
- Previous research experience and scientific publications, if you have them;
- Personal interests and involvements.

2. Motivation letter for participation in the specific doctoral competition.

With the motivation letter (of about 2 pages) you introduce yourself before the commission. Please describe in it:

- Your educational and professional path;
- Your academic interests and strengths;
- Your intention and goals in applying for a PhD in chosen field.

3. If desired, the candidate can provide one of his written scientific work of a maximum of 45,000 characters (25 standard pages): term paper, chapter/part of thesis or master's thesis, scientific publication.

SYLLABUS OF SUBTOPICS:

The syllabus consists of subtopics and basic scientific resources, which is recommended to the candidate for PA doctoral programme to consider in the process of preparing his / her concept for the exam. The description of the dissertation research project during the exam must demonstrate knowledge of a mandatory minimum theoretical basis in the given research field.

The candidate for doctoral studies is also expected to present his / her specific interest in the topic - knowledge of data, research, various publications, the state of the sector, special problems, etc.

In particular, preparation for this exam involves:

- The doctoral candidate has to pre-select one of the subtopics described in the syllabus, in which he will develop his future dissertation;
- The candidate-doctoral student gets acquainted with the applied literature for preparation or other of his choice, but in the given thematic area;
- The PhD candidate considers in advance the elements of the research dissertation project and searches for specific information and literature;
- The PhD student is acquainted in advance with the requirements set out below for the "research project".

Research project: development guidelines:

Describe the proposed research topic as accurately as possible.

The project must contain answers to the following questions:

- What is the problem that underlies your interest in the topic?
- What are your main research questions?
- What literature on the subject you know and what are its limitations?
- What are the main hypotheses of the work?
- What methodology do you intend to apply (justify your choice)?

Explain your expectations:

- How do you intend to conduct your research?
- What type of information (empirical material) will you need and how do you intend to collect and analyze it?
- What research results do you aim to achieve?

1. **First part (four hours of written work):** The doctoral candidate describes his future research project within one of the thematic areas proposed below.

2. **Second part (oral presentation):** Interview on the submitted project and the submitted documents (CV and cover letter).

Only candidates who received a grade not lower than "very good" (4.50) on the first written part of the exam are allowed to participate in the interview.

EVALUATION:

Successfully passed the competition are the candidates who received an average grade from the written and oral exam at least "very good" (4.50).

When enrolling in a doctoral programme, the final topic of the dissertation is definite after discussion with the supervisor and is approved at a department meeting and by the faculty council.

Criteria for evaluating the written development of research dissertation project are:

- Completeness of the research project according to the previously indicated requirements;
- Clarity and argumentation of research questions and expected results;
- Knowledge of the indicated or other literature in the given thematic area;
- Demonstration of interest in the topic (reference to data, research, publications);
- Ability for critical analysis in the exhibition.

THEMATIC PROGRAM (SYNOPSIS) OF THE DOCTORAL COMPETITION IN 3.3 POLITICAL SCIENCE (PUBLIC ADMINISTRATION):

The candidate preliminarily and freely chooses the thematic field in which he / she develops a research project, as well as the elements of the content of the field, corresponding to his / her project.

The indicated literature is not obligatory, but guiding.

Applicants are expected to search for literature themselves in accordance with the selected project.

1. First thematic area - Public policies - theory and methods. Sectoral policies: Security policies; Minority policies and anti-discrimination; Social Policy.
